General Rules and Regulations for On-Site Camping

(A Camping Request Form must be submitted by each camper.) Camping at the WEC is limited to those participating in or attending an event or activity on the facility. This includes overnight stalling of livestock.

The Winnemucca Events Complex (WEC) has 50 campsites on the facility. Each space contains a 30 AMP electrical outlet. Water and one dump station is available in the area.

NOTE: On-site camping is available only to those participating in or attending an event or activity on the WEC. This includes overnight stalling of livestock. All others, or those desiring full hookups, showers, swimming pool and other amenities are encouraged to utilize one of the three commercial RV parks located in Winnemucca. Dry camping and a limited number of additional locations with electrical is available throughout the facilities.

CAMPING FEES

Campsites w/30 amp outlet. (Must be paid with entries) — \$20/night

Other on-grounds camping w/limited electrical. (stall area) — \$20/night

CAMPING RULES

- ◆ Non-contained fires for cooking or heating are not permitted.
- ◆ All campsites must be kept clean for the enjoyment of all occupants. Occupants must clean up after their livestock/pets.
- ◆ Livestock may not be tied to camping vehicle or in temporary stalls in campsite at night (must use permanent stalls/pens).
- ◆ Dogs must be controlled at all times. Do not allow your dog to run free or pose a threat to other campers. Dogs not allowed in grandstands or other buildings.
- ◆ Generators are only allowed to run from 6am to 10pm. Please be considerate of those around you. If it is not absolutely necessary to run your generator, don't!
- ◆ Quiet time is from 10pm to 6am. This includes radios, barking dogs and parties. Any guest, their children, or their visitors who become a nuisance will be asked to leave the grounds.
- ◆ All refuse is to be deposited in containers provided.
