## *Winnemucca Mule 4 yr. Old Derby - 2011 Nomination*

1. For four year olds (foals of 2007).
2. Estimated purse of \$2,000.
3. Distance 400 yards.
4. Weight 122 lbs.
5. **Nomination Fee — \$250.00 Payable:**
  - \$100.00 on or before March 31, 2011
  - \$75.00 on or before April 10, 2011
  - \$75.00 on or before May 1, 2011**Late penalty** — \$100.00 plus fees if received after April 11, 2011  
\$150.00 plus fees if received after May 2, 2011
6. If payments are not postmarked on or before the due dates shown above, nomination will be considered scratched. **NO REFUNDS!!!**
7. Owners/trainers are responsible for providing their own riders.
8. Jockeys must wear a safety vest during the races. Track will not provide any type of protective vest.
9. If nominee is sold, the entry goes with the mule and may be kept up by new owner.
10. **Refunds:** There will be **no refunds** for any reason.
11. All owners and trainers must be member in good standing of the A.M.R.A.
12. All nominees shall be registered with the A.D.M.S.
13. All nominees will be mouthed for age and tattooed by an authorized tattoo agent.
14. Names of animals must be submitted with the May 1, 2011 payment.

15. Purse distribution: Purse includes nomination fees, added money, penalties and forfeitures.

### Consolation

A consolation race will be run consisting of the next eight fastest mules as determined by trials. The total purse will be distributed as follows:

17. The Winnemucca Mule Show and Race Committee, the Humboldt County Ag. District #3 and the Board of Directors of the American Mule Racing Association reserves the right to cancel, reschedule or move this 4 yr. old Derby.
18. All trials, consolation and finals will be run in accordance with the American Mule Racing Association racing rules and the Nevada State Gaming Control Board Rules and Regulations.
19. Tests will be conducted on first place in the finals, first place in the consolation, and first place in the trial races, and at random, if deemed necessary.
20. If less than eight entries are received, purse distribution will be adjusted accordingly.
21. Eight fastest mules will run in the finals and all others will run in consolation race.
22. **Please remember that you still need to enter your animal on entry date - Thursday, June 2, 2011 — 8:00am - 9:30am for the race on Saturday. Call (775) 623-2220.**
